## Virtual Case Rounds for MAACS Roster Attorneys

### How to Register:

Limited to the first 6 participants to register. Registration closes 5 days before event.

### What are Case Rounds?

- Case Rounds consist of a group of approximately 6 attorneys who bring case-specific issues to the group for discussion, brainstorming, and collaboration.
- This session will be for discussion of trial appeal cases only. (See below for additional sessions).
- Each attorney will have a chance to discuss their case issue and seek input from the group. Attorneys should come with one specific case issue to discuss.

### What kind of technical capabilities do I need to participate in Case Rounds?

There are 3 options:

1. **Join on a device with a camera, speakers, a microphone, and an internet connection** (i.e., a cell phone with a camera or a laptop with a webcam): All participants will be able to see and hear you and you will be able to see and hear all participants. [PREFERRED METHOD].
2. **Join on a device with speakers, a microphone, and an internet connection** (i.e., a computer without a webcam): All participants will be able to hear you and you will be able to hear all participants.
3. **Join by phone:** All participants will be able to hear you and you will be able to hear all participants.

### Who will be at Case Rounds?

- Case Rounds are open to MAACS Roster Attorneys only. The maximum number of participants is 6. This session is open only to MAACS Roster Attorneys with trial appeals. Additional sessions offered below.
- Case Rounds will be hosted by SADO attorney Marilena David-Martin. The host will help facilitate the discussion.

### **What happens after I register?**

- You will be notified whether your registration has been accepted.
- An email will be sent out two days before the session that will include the name of all attorney participants and with technical information to help ensure a smooth process.
- You will be asked to email Marilena directly with the name of your client whose case you wish to discuss, along with any known co-defendants. Marilena will ensure there are no attorneys representing co-defendants on the same Case Round call.
