ORDER GRANTING DEFENDANT'S BOND ON APPEAL

NOW COMES the Court, having reviewed the pleadings submitted by counsel, conducting oral argument with the parties, and upon further consideration of Defendant's serious health problems the court has decided to reconsider its decision denying Defendant's motion and GRANT Defendant's Motion for Bond Pending Appeal.

IT IS FURTHER ORDERED that Defendant shall be immediately released from the Michigan Department of Corrections.

IT IS HEREBY ORDERED that Defendant is hereby to be released upon a \$25,000.00 personal recognizance bond.

IT IS FURTHER ORDERED, that as a condition of said bond Defendant shall have no contact, direct or indirect, with the complainant, Nicole Chase.

IT IS FURTHER ORDERED that Defendant shall not possess or own and firearms.

IT IS FURTHER ORDERED that Defendant shall not comsume any alcohol or unprescribed controlled substances. IT IS FURTHER ORDERED that Defendant shall be given an in home PBT devise by the community corrections staff at the county jail. Defendant shall be tested twice daily.

IT IS FURTHER ORDERED that within 24 hours of release from the Michigan

Department of Corrections Defendant shall appear at the county jail where the community

corrections staff will fit Defendant with an GPS device.

IT IS FURTHER ORDERED that Defendant shall not drive any motorized vehicles and surrender his drivers license and passport if he has one, to the community corrections staff at the county jail.

IT IS FURTHER ORDERED that Defendant shall reside at 7019 Karlin Rd. Interlochen, Michigan 49643.

IT IS FURTHER ORDERED that Defendant shall be permitted to walk up to one mile from his home for recreational purposes or to acquire necessities.

IT IS FURTHER ORDERED shall be permitted to ride as a passenger in a motor vehicle for the purpose of doctors appointments, or verifiable emergencies.

IT IS FURTHER ORDERED that Defendant agrees with the following additional provisions:

- a. Defendant agrees to prosecute his appeal to disposition.
- Defendant agrees to surrender himself to the Grand Traverse County Sheriff if the sentence and/or conviction is affirmed on appeal.
- Defendant agrees to appear in the trial court if the case is remanded for further proceedings, or if the conviction is reversed and a new trial is ordered.

- d. Defendant agrees to remain in Michigan unless the court gives him written permission to leave.
- e. Defendant agrees to notify the trial court clerk af any change in address.
