**Option 3. MAACS Roster Attorneys Only: Appointed Appellate Counsel Web Subscription, \$250.**

Access to all of the resources described in Options 1 and 2 above PLUS additional research support, including an annual subscription to Westlaw, allowing unrestricted access to all state and federal case law and secondary legal sources and more; an annual membership to the National Association for Public Defense, allowing access to hundreds of free trainings, webinars, and additional resources; and CDRC/MAACS Research Support Services, including consultation and support in use of the above services in court-appointed appellate matters.
