**ORDER FOR AUTHORITY**  
**TO SETTLE CLAIM AND DISTRIBUTE PROCEEDS**

Upon petition of the Personal Representative pursuant to MSA Sec. 27A.2922; MCL Sec. 600.2922, seeking leave of court to enter its order approving a proposed settlement, and there being no conscious pain and suffering, funeral and burial expenses paid, authorizing distribution of net proceeds and approving counsel fees and expenses and the court being advised in the premises,

**IT IS HEREBY ORDERED AND ADJUDGED** that Plaintiff's motion be and is hereby granted and further that the proposed settlement in the amount of \$4,075,000.00, paid by Defendants to the Personal Representative in exchange for a stipulated order of dismissal, be and is hereby approved.

**IT IS FURTHER ORDERED** that, from the settlement proceeds, Personal Representative shall pay their attorneys, David A. Robinson and Associates, P.C. and Cochran, Neufeld and Scheck, LLP the sum of \$1,326,566.25, representing attorney fees and to reimburse advanced costs in the amount of \$95,301.27.

**IT IS FURTHER ORDERED** that the balance of the settlement proceeds (after payment of counsel expenses and fees) shall be distributed by Plaintiff as follows:

- (a) Ruth Harlin, Sister; \$ 200,000.00
- (b) Tia Glenn, Daughter; \$1,187,566.24
- (c) Nona Dennard, Daughter; \$1,133,566.24
- (d) Ruby Reeves, Sister deceased \$ 0.00


(c) William Lloyd, Brother \$ 100,000.00

**Total: \$2,621,132.48**

**IT IS FURTHER ORDERED** that from the settlement proceeds the Personal Representative, pursuant to MCLA 700.3804 and MCLA 700.3806, shall pay Claimant of the Estate, Herb Strather, reimbursement in the amount of \$7,500.00 for a loan extended to the deceased before his death made on or about August 5, 2004 and that she be allowed to set aside administration fees for the Estate due and owing to attorney Howard Linden in the amount of \$7,500.00. Further, that she be allowed to pay to Ron Hardy the amount \$15,500.00 for rent owed by the deceased for premises rental; and the Personal representative to be reimbursed for funeral expenses in the amount of \$1,500.00.

**IT IS FURTHER ORDERED** that the Personal Representative be and is hereby authorized to execute all documents necessary to effectuate the above settlement, including a release agreement and a stipulation to entry of an order of dismissal.
