# MOTION TO COMPEL PRODUCTION OF DEFENSE TRIAL COUNSEL'S CASE FILE

Defendant BRANDON KIJUAN FIELDS, by and through his attorney, the STATE APPELLATE DEFENDER OFFICE, by MEREDITH KRAUSE, moves this Honorable Court to grant this Motion to Compel Production of Defense Trial Counsel's Case File in this case and says in support thereof that:

- 1. Defendant was convicted of second-degree murder, assault with intent to murder, and felony firearm, on August 23, 2011, before the Honorable Allen L. Garbrecht in the Calhoun County Circuit Court.
- 2. On September 29, 2011, Defendant was sentenced to imprisonment for 28 years to 50 years for second-degree murder, 18 years to 30 years for assault with intent to murder, and 2 years for felony firearm.

- 3. The State Appellate Defender Office (SADO) was appointed to perfect an appeal and/or pursue post-conviction remedies on October 10, 2011.
- 4. On October 26, 2011, SADO mailed a letter to Attorney Virginia C. Cairns, who represented Mr. Fields at trial, requesting a copy of Mr. Fields' case file including discovery, and offering to either make those copies at SADO's expense or reimburse Ms. Cairns for reasonable expenses. (Attached as Appendix A).
- 5. On November 4, 2011, SADO received a response from Attorney Cairns requesting a sum of \$1.00 per page for a copy of her file. (Attached as Appendix B).
- 6. A subsequent telephone message from SADO to Attorney Cairns requesting clarification and additional information was answered by letter received by SADO on January 18, 2012, requesting a prepaid sum of \$850.00 to provide the documents. (Attached as Appendix C).
- 7. On February 22, 2012, SADO Deputy Director Jonathan Sacks attempted to contact Attorney Cairns by phone to discuss a reasonable copy charge; however that call was not returned as of the signing of this motion.
- 8. This Court has ancillary jurisdiction to hear and consider a Motion to Compel Production of Defense Trial Counsel's Case File. See, e.g., *People v Washington*, 134 Mich App 504, 509; 351 NW2d 577 (1984) ("The original and exclusive jurisdiction of the Recorder's Court over felonies committed in Detroit includes the ancillary power to return property to those from whom it has been seized for use as possible evidence").

- 9. Mr. Fields is entitled to the effective assistance of counsel on appeal. Const. 1963, art 1, § 20; Evitts v Lucey, 469 U.S. 387 (1985). In order to render effective assistance of counsel on appeal, counsel must review the discovery provided to Attorney Cairns as well as her complete file to determine the merit of any potential issues on appeal. A signed authorization from Mr. Fields to release otherwise privileged documents is attached as Appendix D.
- 10. Attorney Cairns has a duty to make Mr. Fields' file available to appellate counsel. Under MRPC 1.16(d), upon termination of her representation, Attorney Cairns must "take reasonable steps to protect ... [Mr. Fields'] interests, such as ... surrendering papers ... to which ... [Mr. Fields] is entitled...." Further, under recently amended MCR 6.005(H)(5), ADM File 2010-15, effective May 1, 2012, "The responsibilities of the trial lawyer who represents the defendant include ... when an appellate lawyer has been appointed or retained, promptly making the defendant's file, including all discovery material obtained, available for copying upon request of that lawyer...."
- 11. An attorney may "properly charge reasonable costs" to locate and copy a client's file. State Bar of Michigan Formal Ethics Opinion R-019. However, Attorney Cairns has demanded \$1.00 per page, or \$850.00 to copy Mr. Fields' file. Commercial rates for copies range from \$0.10 to \$0.13, which SADO remains willing to pay. Furthermore, SADO was willing to pick up the file, copy it on SADO's equipment, and promptly return the file to Ms. Cairns.

WHEREFORE, Defendant respectfully moves that this Honorable Court grant this Motion to Compel Production of Defense Trial Counsel's Case File and order Attorney Virginia Cairns to either (1) make her file available forthwith to the State Appellate Defender Office for copying at SADO's expense and return; or (2) provide the previously requested copies upon tender of \$0.10 per page, or \$85.00.
